Introduction

Research funding has long been considered as one of the main determinants of scientific activities. Identifying funding sources is indispensable to develop and implement scientific research projects that aim to develop new technologies and tools to improve societal wellbeing and thereby contribute to achieving the UN Sustainable Development Goals (SDGs). The UCC Corporate Strategic Plan (2018-2022) and the UCC Research Agenda (2018-2022) both underscore this imperative. In this context, it is essential that relevant information on funding opportunities is made available and accessible, particularly to researchers in developing countries where immediate action on a plethora of socio-economic and human health challenges are required. While general information about the respective discipline-specific funding agencies exists in the public domain, a critical component of accessing funds is the ability to make sense of the respective nuances and areas of interest of the various funders. For example, not every organization has specific calls for health outcomes but may have more generic calls for proposals or general open invitations that can also apply to health outcomes but are not utilized by the community; or funders may be interested in funding only some aspects or areas of research. Since individual funding organizations follow internal processes and rules for proposal acceptance, review and funding, investigators need to be knowledgeable about these differences to recognize how best to leverage research support for their projects and how to strategically target relevant aspects of research projects to the most appropriate funding organizations and funding opportunities. This is particularly important for cross-cutting projects that span multiple sectors that are not within the mission and resources of one particular funding agency. The purpose of this Research Grants and Online Resource Compendium is to help guide investigators in properly approaching existing funding sources/product development resources to structure large scale, or cross-cutting research projects. The Directorate of Research Innovation and Consultancy (DRIC) has taken the task of developing this compendium of research funding institutions describing key characteristics and information about funding opportunities across different research fields. The Compendium also has information on freely available online research tools, journals and books. It is expected that this document will be updated periodically to expand on the number of funders contributing to the compendium, and adapt time-sensitive information as appropriate. In addition to researchers, we hope this document will also help inform other stakeholders, including other funders, about various funding and product development resources available to support scientific research projects. It is the first attempt by DRIC to optimize information on available research funding for UCC academics and the scientific research community at large, by creating an improved understanding of the mission, strategy and application mechanisms of major research funding organizations. We anticipate that all colleagues will find this source document useful.

The Academy of Sciences for the Developing World (TWAS): TWAS Prizes and Grants

Summary TWAS, the academy of sciences for the developing world, is an autonomous international organization, founded in 1983 in Trieste, Italy, by a distinguished group of scientists from the South under the leadership of the late Nobel laureate Abdus Salam of Pakistan. It was officially launched by the secretary-general of the United Nations in 1985. TWAS represents the best of science in developing countries. Its main mission is to promote scientific excellence and capacity in the South for science-based sustainable development.

The Academy's strength resides in the quality and diversity of its membership -internationally renowned scientists elected by their peers. TWAS Fellows, who represent 85 percent of the membership, are citizens of the South; TWAS Associate Fellows are citizens of the North who have made significant contributions to the advancement of science in the South. At present, TWAS has 902 members from 90 countries.

Here is a brief overview of the prizes and grant programs offered by TWAS to scientists in developing countries:

PRIZES: Honoring scientific achievement

The Ernesto Illy Trieste Science Prize

TWAS and illycaffè, in collaboration with the Municipality of Trieste and the Fondazione Internazionale per il progresso e la libertà delle scienze, have established the Ernesto Illy Trieste Science Prize, to honor outstanding scientific achievements made by individual scientists from the developing countries.

TWAS Prizes

Each year the Academy awards eight prizes of US\$15,000 each to individual scientists who have been working and living in a developing country for at least ten years. The Prizes are given in the following eight fields of science: agricultural sciences, biology, chemistry, earth sciences, engineering sciences, mathematics, medical sciences and physics.

Deadline: 31 March.

The TWAS-AAS-Microsoft Award for Young Scientists

The Prize will recognize young scientists in Africa whose research in computer science promises to have a positive impact in the developing world. Each year, three winners will be selected from different countries on the continent. Each recipient will receive a Euro 7,000 (approx. USD9,800) cash award generously contributed by Microsoft.

Deadline: 15 May.

TWAS Prizes to Young Scientists in Developing Countries:

The Academy invites national science academies, scientific research councils, ministries of science and technology and high-level research organizations in the South to institute a scheme of TWAS prizes for young scientists in their countries.

Important: The programme is directed at organizations, not individual scientists.

Deadline: none.

TWAS Medal Lectures

Every year, the Academy honors three TWAS Members for their achievements in their fields of research. The recipients lecture on a main aspect of their work, and are presented with a plaque.

The Abdus Salam Medal for Science and Technology

The medal was instituted to honor the Academy's founder and first president, Professor Abdus Salam. It is awarded to highly distinguished personalities who have served the cause of science in the Third World.

The C.N.R. Rao Prize for Scientific Research

The prize, named after TWAS Founding Fellow and former president, CNR Rao, carries a cash award of US\$5,000 and is usually presented every three years. It is designed to honor distinguished scientists from the developing world, especially scientists from the world's scientifically and technologically lagging countries, who have made significant contributions to global science.

GRANTS: Building scientific capacity

The TWAS Research Grants Programme in Basic Sciences was established in response to the needs of researchers in developing countries, particularly those attached to institutions that lack appropriate research facilities. Under this scheme, grants can be awarded for research projects in Biology, Chemistry, Mathematics and Physics either to

individual young researchers, or to research units in the science-and-technology-lagging countries (S&TLC) identified by TWAS, to enable them to purchase the research facilities they need to enhance their productivity.

TWAS Research Grants are awarded to high-level promising research projects in Biology, Chemistry, Mathematics and Physics carried out by individual scientists in the S&T-lagging countries (S&TLC) identified by TWAS. Research Grants to individual scientists amount to a maximum of USD 15,000. The grants, which are normally provided for a period of 24 months, may be used to purchase scientific equipment, consumables and specialized literature (textbooks and proceedings only). They do not cover salaries of researchers and/or students, field expenses, or travel expenses. In addition, the purchase of laptops and laboratory animals is not supported.

Individual applicants must be nationals of developing countries. They must hold a PhD, be at the beginning of their careers, but already have some research experience. They must hold a position at a university or research institution in one of the S&TLCs and be under 45 years of age.

Applicant must at the time of application NOT have an active research grant with TWAS or OWSD Early Career Women Scientists (ECWS) Fellowship.

Applications from women scientists and those working in Least Developed Countries are especially encouraged.

You must submit a strong Research Proposal, you may find further information on how to write a strong proposal by visiting AuthorAID. Individual scientists who submit a satisfactory final report on a previous grant may apply for a renewal.

Please be advised that applicants may apply for only one programme per calendar year in the TWAS and OWSD portfolio. Applicants will not be eligible to visit another institution in that year under the TWAS Visiting Professor programmes. One exception: The head of an institution who invites an external scholar to share his/her expertise under the TWAS Visiting Professor programmes may still apply for another programme.

AEON Environmental Foundation

Deadline NA
Amount A total of 100 million yen (approx. USD 1,015,000) of grants is to be awarded every year.
Eligibility NPOs, NGOs and individuals that strive earnestly and continuously to conserve the global and regional environments.
Location Developing countries and Japan
Summary The AEON Environment Foundation was formed in 1991 with the object both of developing its own environmental conservation activities, and supporting the work of other groups with similar objectives.

The aid has been implemented every year since 1991, and including the 16 year of support, 2006, a total of 1,623,390,000 yen (approx. USD 16,477,000) has been donated to 1,887 organizations. A total aid of 100 million yen was provided for field work focused on environmental conservation activities in developing countries and Japan in 2007. In addition, in order to advance global environmental conservation a step further, a new 100 million yen assistance to research institutes that are studying to reduce CO₂.

The aims of their work:

1. To implement, aid, and otherwise support work aimed at ensuring environmental conservation in developing countries.
2. To implement, aid, and otherwise support environmental conservation work in tree-planting and afforestation areas.
3. To perform the work required to achieve other goals of the AEON Environmental Foundation.

Africa Bird Club (ABC)

Deadline	End of February, June and October every year
Amount	ABC Conservation Awards - Maximum Grant £3,000 ABC Expedition Awards - Maximum Grant £5,000
Eligibility	As the fund is small, several restrictions will apply: <ul style="list-style-type: none">▪ applicants must be normally resident in Africa;▪ ideally, the requested grant from ABC should be a major part of the project budget;▪ requests for contributions towards academic fees will not normally be considered;▪ however funding for field projects that are being carried out as part of an academic study may be considered if funding from the academic institution is not available;

Location Africa

Summary The ABC's Conservation Programme supports small to medium sized conservation projects in Africa. Since 1996, it has supported a wide variety of projects including training courses, research into threatened species and promotion and awareness of conservation issues in Africa.

The Club aims to encourage as wide a range of ideas as possible, and funds approximately 10-15 Conservation Awards each year. Many different types of project can be considered so long as there is a clear conservation objective. These could include:

- survey and research into African birds;
- educational projects or training courses;
- production of guides to the common birds of a country in local languages;
- interpretation material for nature reserves;
- other ideas will be considered.

The African Bird Club gives out a smaller number of Expedition Awards each year for larger, more ambitious projects. These usually involve the proponent travelling to a foreign country to undertake the project.

Amount Organizations can apply for grants ranging from \$1,000 - \$40,000. Kindly note that most grants will be for less than the maximum. Grants over \$20,000 are only made to organizations which operate on a regional basis.

Eligibility Organizations can be local, national, sub-regional or regional African women's organizations, from any part of Africa. Local women's organizations should send in the names of two referees, one of whom should be a member of a women's organization that operates nationally.

Summary Poverty and hunger in Africa are inextricably linked to the plight of smallholder farmers, who produce most of the continent's food but struggle with unproductive soil, unreliable water supplies, low-quality seeds, and scarce markets for their crops.

Alliance for a Green Revolution in Africa (AGRA) was founded in 2006 on the belief that investing in agriculture is the surest path to reducing poverty and hunger in Africa. It works across the continent to help millions of smallholder farmers—who make up 70 percent of Africa's population—boost their farm productivity and incomes.

AGRA has supported more than 400 projects, including efforts to develop and deliver better seeds, increase farm yields, improve soil fertility, upgrade storage facilities, improve market information systems, strengthen farmers' associations, expand access to credit for farmers and small suppliers, and advocate for national policies that benefit smallholder farmers.

AGRA aims to play a central role in transforming the agricultural sector in Africa and its food system—in a way that is tailored to conditions in Africa and places a strong emphasis on safeguarding the environment. AHRC Global Challenges Research Fund (GCRF)

Deadline October 31, 2020
Amount £150,000 for a period of up to 12 months
Eligibility Eligible projects must be fully compliant with the requirements of Official Development Assistance (ODA), addressing a development need or challenge with the potential to support low or middle income countries meet the UN Sustainable Development Goals (SDGs). In addition, applications must demonstrate the case for urgency, explaining why the research needs to be done within specified time constraints that cannot be supported through other funding routes.

Applicants interested in applying should first submit an expression of interest to the AHRC (see link below) at the earliest opportunity following the emergence of the urgency need. The AHRC will aim to provide eligibility decisions within five working days of receipt.

If the expression of interest is considered to fall within the scope of the scheme, applicants will then be invited to submit a full application via Je-S for consideration through an accelerated peer-review process. Where feasible, AHRC aims to complete the review process within four weeks from submission of the full proposal

Location Low and middle income countries
Summary Recognising the fast-moving nature of many of the challenges facing low or middle income countries (LMICs), the AHRC has launched this scheme to provide an accelerated funding outlet for urgent research priorities. Funded as a part of the Global Challenges Research Fund (GCRF), it is an open, responsive mechanism through which arts and humanities

researchers (working with other disciplines where appropriate) can respond in an agile way to unanticipated urgent research needs.

All projects should have the potential for budgetary self-sufficiency (direct and indirect costs) or show evidence that special funds will not be needed to continue the program after completion of the grant period. The Allen Foundation Inc. imposes a cap of twenty percent (20%) for overhead costs collected (on top of direct costs of completing the project) by colleges and universities

Amount Prince Talal International Prize for Human Development, carries a financial reward of US\$ 1,000,000, awarded annually by the Arab Gulf Programme for Development (AGFUND).

Eligibility No one can nominate his/her or its project. However, each of the following entities is eligible, as third party, to nominate for the Prize; UN organizations, regional, international and national NGOs, governments agencies, public institutions, universities and research centers, syndicates and experts in the field.

Summary

Since its establishment in 1999, the prize has been known as AGFUND International Prize for Pioneering Human Development Projects. Following the passing away of His Royal Highness Prince Talal bin Abdul Aziz Al Saud, founder of AGFUND, in December 2018, the AGFUND's Board of Directors decided to rename the prize after the late Prince Talal. This decision was taken to commemorate his lifelong dedication to the service of human development and poverty alleviation through AGFUND and the other institutions he established. Hence, the prize new name is "Prince Talal International Prize for Human Development".

Idea of the Prize

Stemmed from AGFUND's approach to enhance development performance and support key development projects, the overall objective behind the Prize idea is to contribute to the efforts aiming to achieve sustainability in development and investment in people.

In this sense, Prince Talal International Prize is considered to be an important tool to identify successful development projects, reward them and disseminate their innovative ideas to best contribute to the improvement of development work. It is also an innovative approach and a strategic instrument to exchange successful experiences to strengthen the mechanisms of development cooperation and project funding with special emphasis on the most prominent factors that militate against development and affect the vulnerable groups, particularly women and children in developing countries. These include poverty, social exclusion, socio-economic marginalization, education and health.

Prize Objectives

1. Support the distinguished efforts aiming at the promotion and development of the concepts and dimensions of human development.
2. Reproduce and disseminate the successful project experiences.
3. Highlight the best practices, which aim to improve the living conditions of the poor and disadvantaged with particular emphasis on women and children.
4. Enhance the exchange of experiences and develop better mechanisms to find solutions to the problems of poverty, marginalization and socioeconomic exclusion of vulnerable groups.

American Anthropological Association (AAA): Solon T. Kimball Award for Public and Applied Anthropology

Deadline Nomination packages must be submitted in time to be received by June 1
Amount Through the generosity of an anonymous donor, the Solon T. Kimball Award for Public and Applied Anthropology now provides a \$1000 prize.

Eligibility The range of eligible nominees is unusually broad: the Kimball Award can be given to individuals or to a team (including collaborators outside of anthropology) and is not restricted by nationality, anthropological specialization, or type of employment. The anthropological contribution may be theoretical or methodological. The impact on public policy may be in any area, domestic or international, for example biodiversity, climate change, energy, international relations, medicine, public health, language conservation, education, criminal justice, development, or cultural heritage. Nominations recognizing disciplinary path-breakers who are shaping and strengthening the discipline of anthropology, and which honor those who might otherwise be overlooked, are especially encouraged.

Location No restrictions

Summary The Solon T. Kimball Award for Public and Applied Anthropology was initiated by royalties from Applied Anthropology in America (Elizabeth M. Eddy and William L. Partridge, eds., 1978), a volume dedicated to Solon Kimball, "who taught that the study of human behavior should be of service to people." The award has been presented every other year since 1984 at the American Anthropological Association Annual Meeting.

The Kimball Award offers an opportunity to honor exemplary anthropologists for outstanding recent achievements that have contributed to the development of anthropology as an applied science and have had important impacts on public policy.

Global Environment Facility (GEF) Project Funding

Amount Since 1991, the Global Environment Facility has provided \$6.8 billion in grants and generated over \$24 billion in co-financing from other sources to support over 1,900 projects that produce global environmental benefits in more than 160 developing countries and countries with economies in transition. GEF funds are contributed by donor countries. In 2006, 32 donor countries pledged \$3.13 billion to fund operations for four years.

Eligibility GEF support is provided to government agencies, civil society organizations, private sector companies, research institutions, among the broad diversity of potential partners, to implement projects and programs in recipient countries.

All projects or programs must fulfill the following criteria to be eligible for GEF funding.

- **Eligible country:** Countries may be eligible for GEF funding in one of two ways: a) if the country has ratified the conventions the GEF serves and conforms with the eligibility criteria decided by the Conference of the Parties of each convention; or b) if the country is eligible to receive World Bank (IBRD and/or IDA) financing or if it is an eligible recipient of UNDP technical assistance through its target for resource assignments from the core (specifically TRAC-1 and/or TRAC-2).
- **National priority:** The project must be driven by the country (rather than by an external partner) and be consistent with national priorities that support sustainable development.
- **GEF priorities:** to achieve the objectives of multilateral environmental agreements, it is required that the GEF support country priorities that are ultimately aimed at tackling the drivers of environmental degradation in an integrated fashion. For this reason, the focal areas (Biodiversity, Climate Change Mitigation, Land Degradation, International Waters and Chemicals and Waste), which remain the central organizing feature in the GEF-7 Programming Directions, provide countries with the opportunity to participate in selected “Impact Programs” focusing on 1) Food systems, Land Use and Restoration; 2) Sustainable Cities; and 3) Sustainable Forest Management (for more details, see annex A of the GEF-7 Programming Directions Documents).
- **Financing:** The project must seek GEF financing only for the agreed incremental costs on measures to achieve global environmental benefits.
- **Participation:** The project must involve the public in project design and implementation, following the Policy on Public Involvement in GEF-Financed Projects and the respective guidelines.

Location GEF funds are available to developing countries and countries with economies in transition to meet the objectives of the international environmental conventions and agreements.

Summary The Global Environment Facility was established on the eve of the 1992 Rio Earth Summit to help tackle our planet’s most pressing environmental problems. Since then, the GEF has provided over \$18.1 billion in grants

It currently works with 10 institutions and faculties in Ghana, Tanzania, Vietnam and Sri Lanka AuthorAid supports women researchers to address the issues preventing them from progressing to senior roles in their institutions.

The Platform is working on establishing the infrastructures, tools, and approaches to make CGIAR data visible and usable, and has developed FAIR Metrics and downloadable Guidelines for making data assets FAIR. It is also working with 15 Centers to build capacity across the CGIAR system to effectively manage its valuable data resources. GARDIAN, the Global Agricultural Research Data Innovation & Acceleration Network, is the CGIAR flagship data harvester. GARDIAN enables the discovery of publications and datasets from the thirty-odd institutional publications and data repositories across all CGIAR Centers to enable value addition and innovation via data reuse. It employs text-mining to enrich the associated metadata to enhance discovery, and will soon test data mining techniques with cleaned, well-annotated datasets to enhance interoperability. Plans for GARDIAN include further demonstration of the value of interoperable data via seamless interactivity of discovered data with key analytical/visualization tools, including models and maps.
